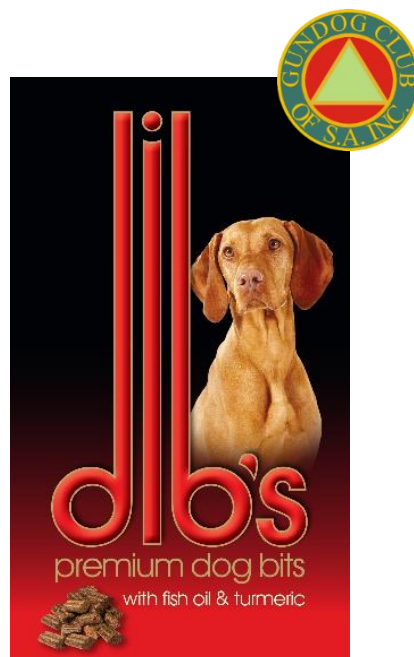

## COVID-19 – ANKC TEMPORARY CHANGE OF RULES

Obedience trials include a number of exercises which may bring the Judge or Stewards and Handler closer than the prescribed 1.5 metres. The ANKC has approved modifications to the rules which will assist in ensuring that there are no inadvertent breaches of the social distancing restrictions.

**Current rule:** Collars and Leads (Page 16):

*The minimum length of lead will be 750 mm and it will be fitted with a quick release fastener. All dogs must enter and leave the Ring on a lead. In exercises that require a dog to be off lead, the lead will be taken off and handed to the Steward at the Start Peg.*

Modify to - the lead will be taken off and retained by the handler at the Start Peg.

**Current Rule:** Heel on Lead (Page 18):

Description of Exercise for the Community Companion Dog, Novice and Open Classes

*The Handler and dog must execute a 'Figure Eight' at normal pace in which they must heel at least twice around two Stewards standing approximately three (3) metres apart. There must be at least one 'Halt' during this portion of the exercise. The Judge may replace a Steward in the 'Figure Eight' or may take the place of a Steward himself.*

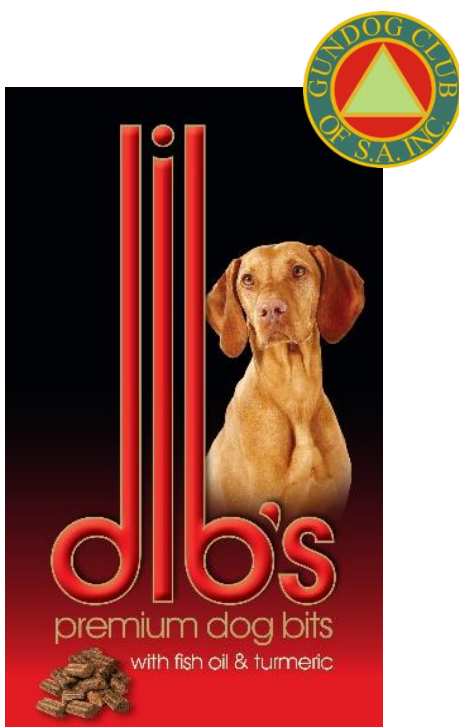
Modify to two Stewards standing approximately four and a half metres apart.

## RULES FOR NOT FOR COMPETITION OBEDIENCE AND RALLY CLASSES AS PER SACA RULES (01/20)

This is a non-qualifying class for dogs who have gained a Community Companion Dog or Novice Obedience title or a Novice Rally title.

Dogs may be entered in any class up to and including the highest title gained by the dog but shall not enter a higher class at the same trial.

The class will be judged in accordance with the normal ANKC Ltd Rules and procedures for that class.

### COVID-19 PROTOCOLS

### OBEDIENCE TRIAL 20/09/2020

These Protocols will be outlined again at the pre-trial briefing by the Trial Manager and be policed by the COVID Marshals, Judges, Trial Committee and Stewards.

- Social distancing is always to be maintained, apart from emergency situations which cannot be foreseen.
- Competitors will ensure social distancing when setting up chairs, dog crates, gazebos etc. and will not congregate in groups.
- At no point during the Trial (including the Presentation Ceremony) will the usual social greetings of welcoming and gestures of congratulations be used.
- Trial competitor numbers will be collected from the check-in desk and laid out for easy collection.
- Qualifiers will be announced post trial and certificates/awards will be laid out for collected from check-in desk.
- Each participant will sanitise their hands upon entry and exit of the ring. Gloves, Sanitiser, Disposable Wipes and Masks will be available at check-in and entry/exit of the ring.
- Judges and stewards will sanitise their hands between each competitor.
- Judges are can examine dogs for the 'Stand for Examine' exercise in the standard manner as they are not in contact with the exhibitor for longer than 15 minutes. This has been confirmed by the SA Government ORSR COVID-19 Support Team.
- Open containers will be placed on ring tables for Competitors to deposit dumbbells, gloves and other trial equipment.
- Separate tongs will be provided for Judges and Stewards for those exercises where they are required.
- All trial equipment will be disinfected during set-up prior to use and when removed from the ring.
- Only individuals directly involved in the duties related to the running and execution of the Trial, or those handling a dog entered at the Trial are permitted on the veranda/check-in or the club rooms at any time. Toilet available with anti-bacterial hand wash. Entry accessed at the back of the club rooms.
- Individuals attending the Trial must sign the Attendance Register, agreeing they understand and will adhere to these Protocols.
- Catalogue for competitors will be electronic only. No hard copies will be available. Catalogue will be emailed to competitors and posted on Facebook minimum 2 days prior to trial.
- All individuals are strongly encouraged to have the COVID Safe app in operation on their phone while at the Trial.
