Competitors please note:

Quite a few people have had to be contacted regarding errors on their entry forms. The main issues have been:

- One entry form for two classes. Please note that as per the current entry forms, **ONE ENTRY FORM TO BE COMPLETED PER CLASS.**
- Height of dog/Jump Height. Please specify which one it is. The older forms don't have a field for Jump Height so either please amend the form or make it clear.
- Entry forms not trimmed to size.

The Trial Secretary's job is difficult enough as it is without having to chase up incorrect entries or cut up entries to size.

All attendees must check in with a QR code or manually on the Contact Tracing Record sheet as per directives by the South Australian Government. Fines apply for non-compliance for both the club and the person concerned.
