

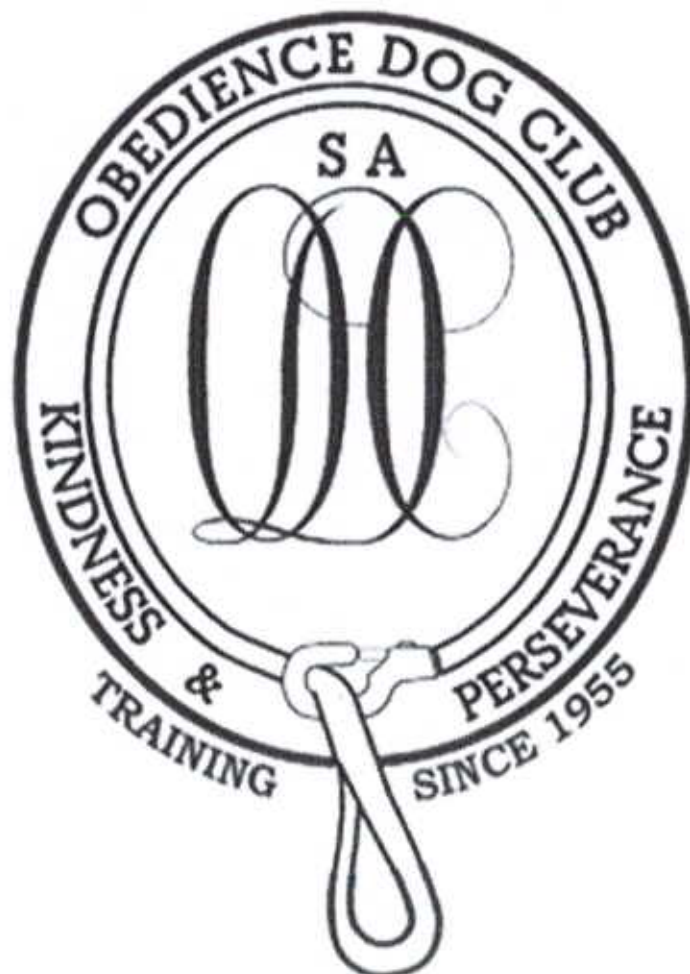

The South Australian Obedience Dog Club would like to welcome everyone to our April Trial and thank you all for your entries. It's great to see so many out in the ring doing what we love best and hope everyone has an enjoyable and successful Day.

The Committee would also like to thank all of the Judges and Stewards for their time and also those helping in the office, with catering, and for those offering their time with planning and running of this trail.

It is asked that all entrants ensure that they report promptly to the ring when called. For those entered in multiple classes, all efforts to avoid clashes have been made and it is asked that you communicate to the ring stewards sooner rather than later if it looks as though you will have a clash on the day. Entrants not reporting to the ring in a prompt manner when called may be scratched. If you are likely to clash it is asked that you prioritise those classes that are run according to height. It is asked that people consider other entrants when walking past and between the rings to avoid distraction for the dog in the ring.
