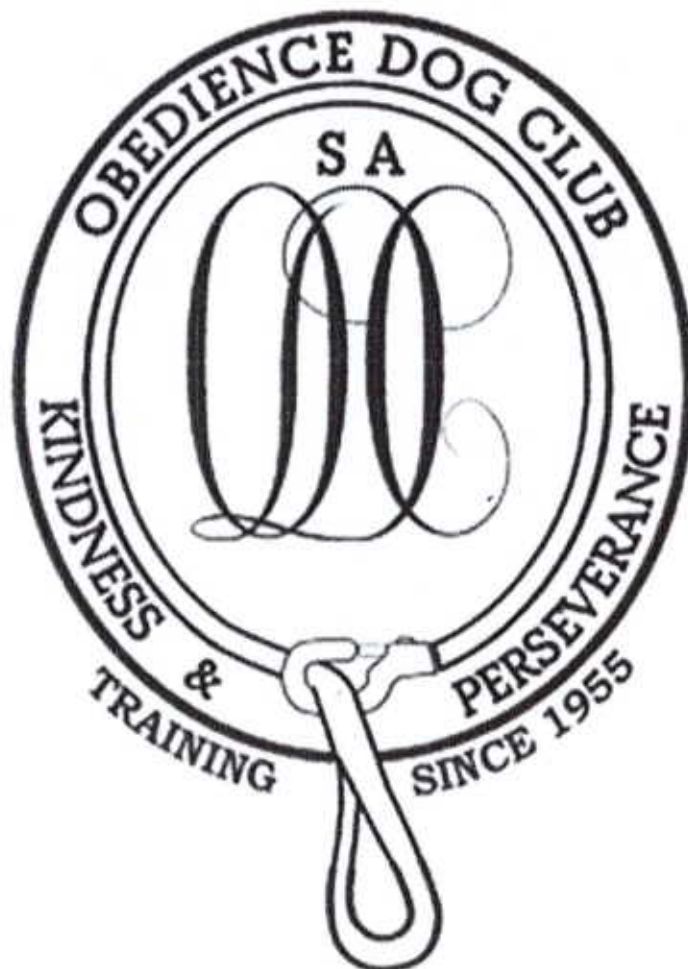

The South Australian Obedience Dog Club would like to welcome everyone to our final Trial for the year and thank you all for your entries. It's great to see so many back out in the ring after such a long forced break and hope everyone has an enjoyable and successful evening.

The Committee would also like to thank all of the Judges and Stewards for their time and also those helping in the office, with catering, and for those offering their time with planning and running of this trail.

It is asked that all entrants ensure that they report promptly to the ring when called. For those entered in multiple classes, all efforts to avoid clashes have been made and it is asked that you communicate to the ring stewards sooner rather than later if it looks as though you will have a clash on the day. Entrants not reporting to the ring in a prompt manner when called may be scratched. If you are likely to clash it is asked that you prioritise those classes that are run according to height. It is asked that people consider other entrants when walking past and between the rings to avoid distraction for the dog in the ring.

Rally COVID-19 Rules

Competitors entering this Competition are required to comply with the COVID-19 restrictions as set out below. If you are not prepared to comply with these Rules, please do not enter our Competition.

- 1.** If you have been overseas in the last 14 days, do not come to this competition.
- 2.** If you are unwell, do not come to this Competition.
- 3.** Competitors must comply with social distancing rules (1.5 metres) when setting up dog crates, gazebos, chairs etc. and will not congregate in groups.
- 4.** For those competitors setting up a gazebo or tent the 1 person per 2 square metre rule applies.
- 5.** Competitors **must use Hand Sanitizer before** entering the Clubhouse area.
- 6.** Every competitor must report to vetting and advise their name and phone number for tracing purposes.
- 7.** Competitors **must use Hand Sanitizer** and comply with social distancing when attending for vetting and passing the checkpoint.
- 8.** Competitors are expected to assist with the set-up and pack up of trial equipment but **must wear single use Gloves** (that will be available).
- 9.** Judges and Stewards **must wear single use Gloves** if handling the Rally signs and Trial Equipment (that will be available).
- 10.** Competitors must not enter the stewards/judges area.
- 11.** There will be a limited number of 10 competitors walking the Rally course at any time.
- 12.** The Competitor must retain their lead.
- 13.** Competitors are advised catering will be available and there will be markers for queuing.
- 14.** Please follow the **ENTRANCE** and **EXIT** signs located on the north side and west side at the Clubhouse veranda.
