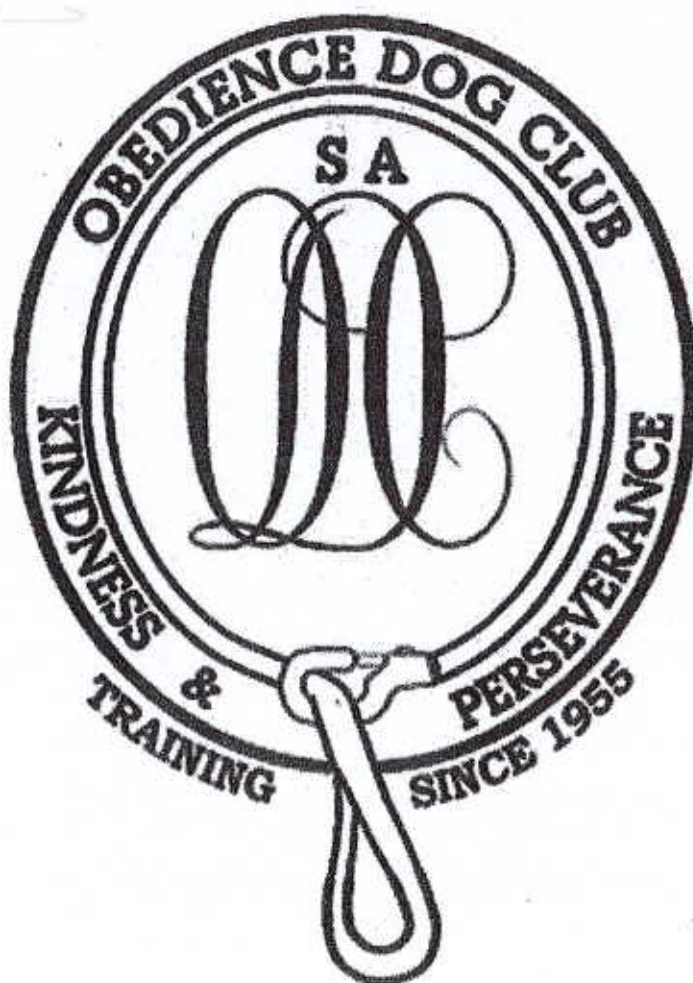

The South Australian Obedience Dog Club would like to welcome everyone to our April trial and thank you all for your entries. It's great to see so many out in the ring doing what we love best and hope everyone has an enjoyable and successful Day.

The Committee would also like to thank all of the Judges and Stewards for their time and also those helping in the office, with catering, and for those offering their time with planning and running of this trial.

It is asked that all entrants ensure that they report promptly to the ring when called. For those entered in multiple classes, all efforts to avoid clashes have been made and it is asked that you communicate to the ring stewards sooner rather than later if it looks as though you will have a clash on the day. Entrants not reporting to the ring in a prompt manner when called may be scratched. If you are likely to clash it is asked that you prioritise those classes that are run according to height. It is asked that people consider other entrants when walking past and between the rings to avoid distraction for the dog in the ring.

Trick Trial COVID-19 Rules

Competitors entering this Competition are required to comply with the COVID-19 restrictions as per the Government rules and SAODC Covid Safe Plan. This applies to all visitors as well. If you are not prepared to comply with these Rules, please do not enter our Competition.

If you are unwell, do not come to this Competition.

Competitors **must use Hand Sanitizer before** entering the Clubhouse area and it is **MANDATORY TO WEAR A FACE MUSK.**

All attendees MUST check-in using the QR code on their MYSA GOV app or provide their name and phone number on the Contract Tracing Record Sheet provided.

Competitors must use Hand Sanitizer and comply with social distancing when attending for vetting and passing the checkpoint.

The Competitor must provide a crate to secure their dog near the assembly area before entering the ring to put out their own props (the steward will not be placing props).

The Competitor must enter the ring and remove their own lead and place on the lead stand provided at the entrance to the ring,

The Competitor **must secure the dog and immediately return** to the ring and remove their props.
